# **Invitation to Bid**

## **For Design and Build of BAGO CITY WATER DISTRICT Two-Storey Admin. Building with Perimeter Fence and Landscaping**

1. The *Bago City Water District*, through the *Corporate Budget for the contract approved by the governing Boards* intends to apply the sum of Php 23,980,000.00 being the Approved Budget for the Contract (ABC) to payments under the contract for Design and Build of the BAGO CITY WATER DISTRICT Two-Storey Admin. Building with Perimeter Fence and Landscaping. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Bago City Water District now invites bids for Design and Build of the BAGO CITY WATER DISTRICT Two-Storey Admin. Building with Perimeter Fence and Landscaping. Completion of the Works is required for 270 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Bago City Water District Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.
5. A complete set of Bidding Documents may be acquired by interested bidders on January 21, 2025 from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest guidelines issued by the GPPB, in the amount of Twenty Five Thousand Pesos (Php 25,000.00) in cash.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of

the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Bago City Water District will hold a Pre-Bid Conference on January 28, 2025, 1:30PM (PAGASA time) at *Bago City Water District – Board Room* which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before February 10, 2025, 10:00 AM (PAGASA time). All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 7.  
  
Bid opening shall be on February 10, 2025, 10:30 AM (PAGASA time) at *Bago City Water District Office*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. The Bago City Water District reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
